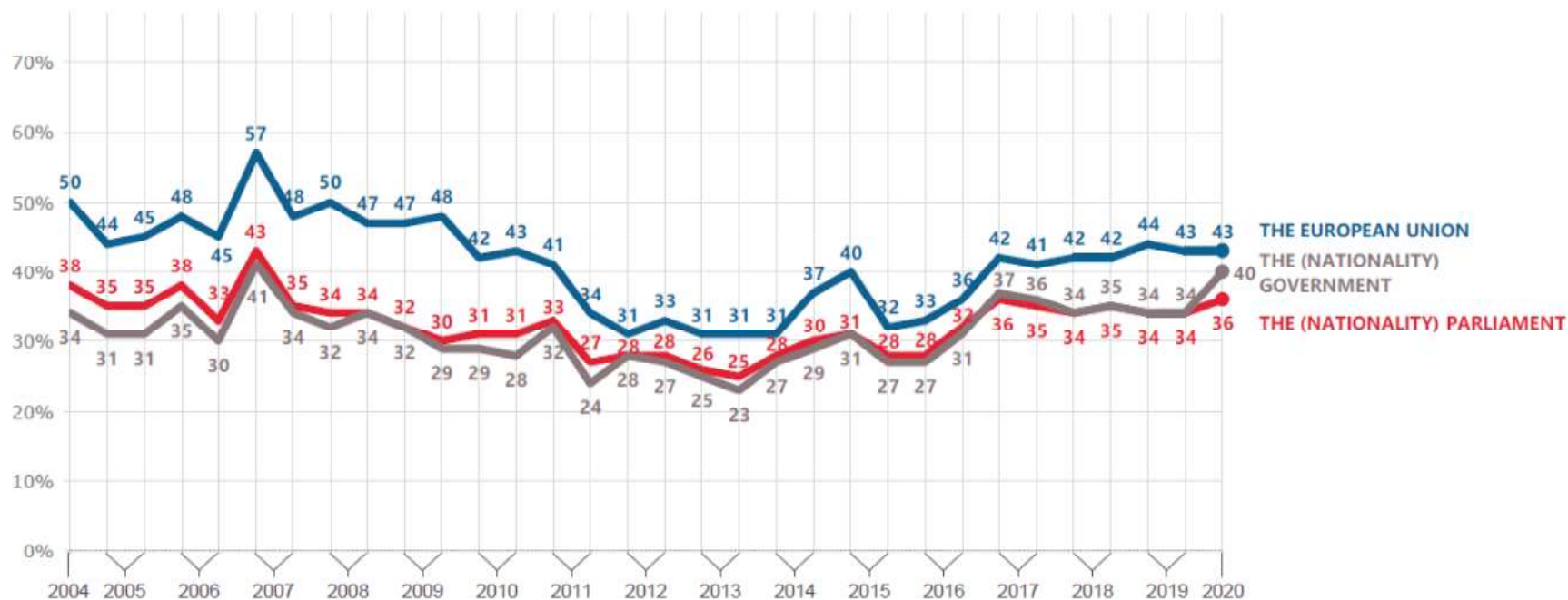

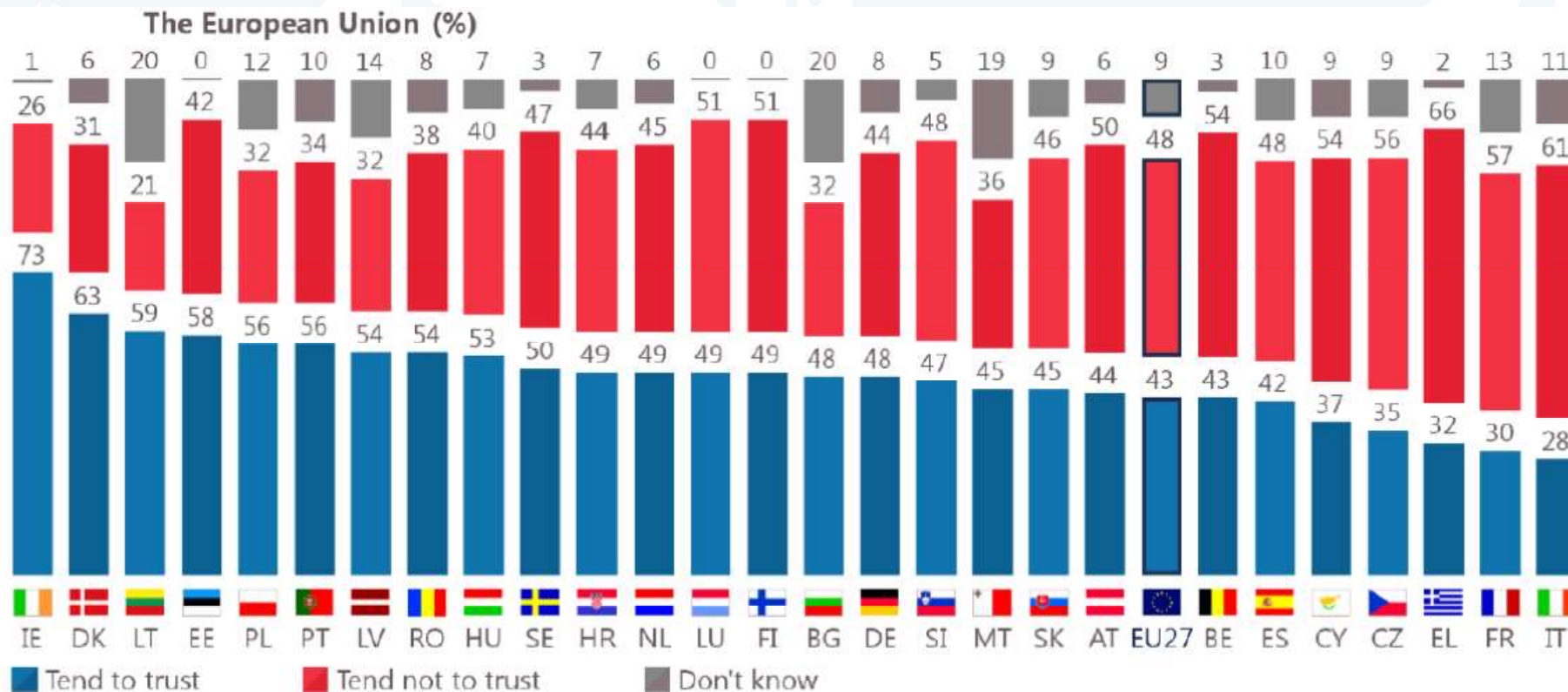


Quanta fiducia hanno (in media) i cittadini UE del proprio Governo, Parlamento e dell'UE?

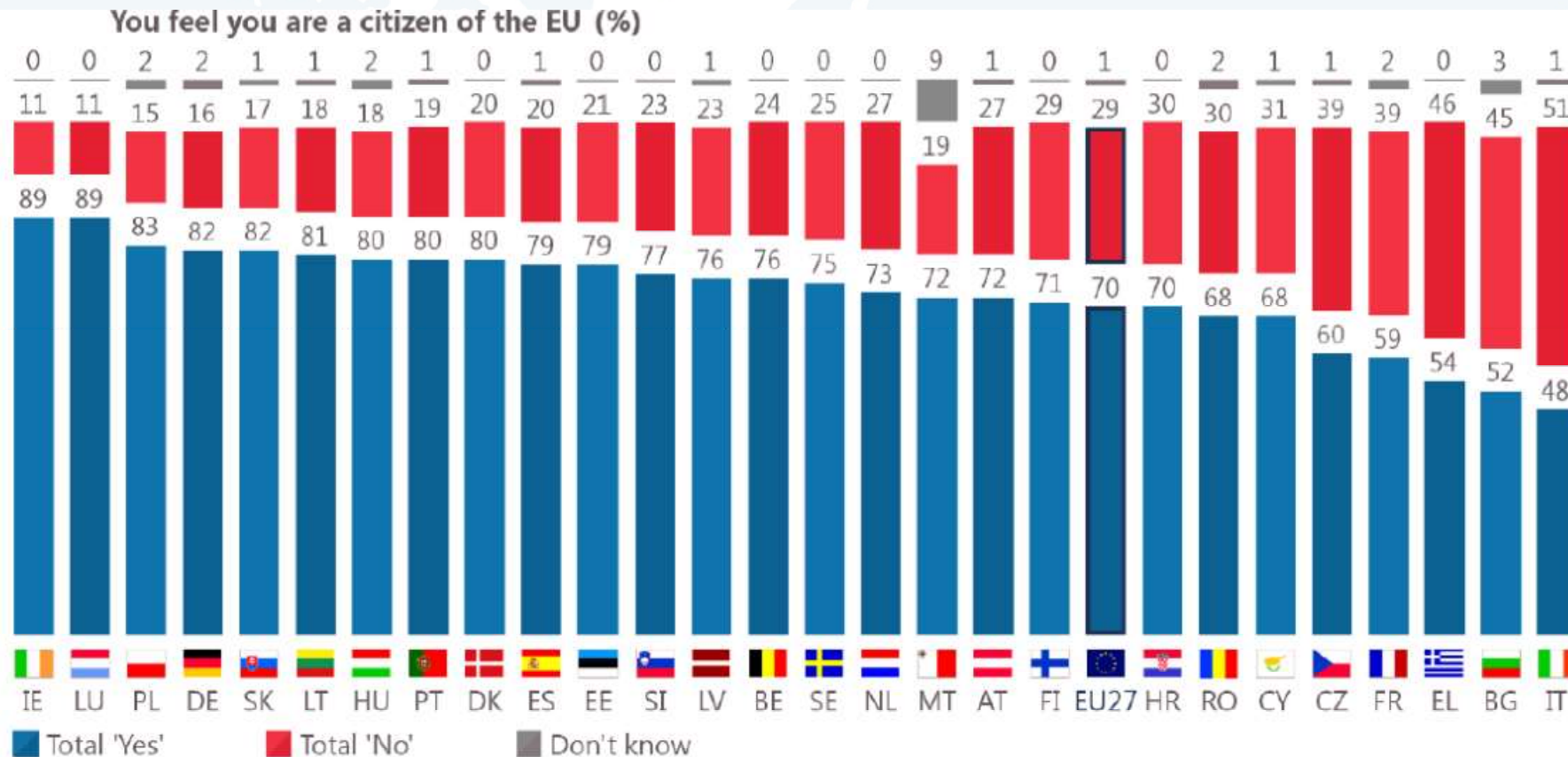
(% - EU - TEND TO TRUST)



Quanta fiducia ha nell'Unione europea ?



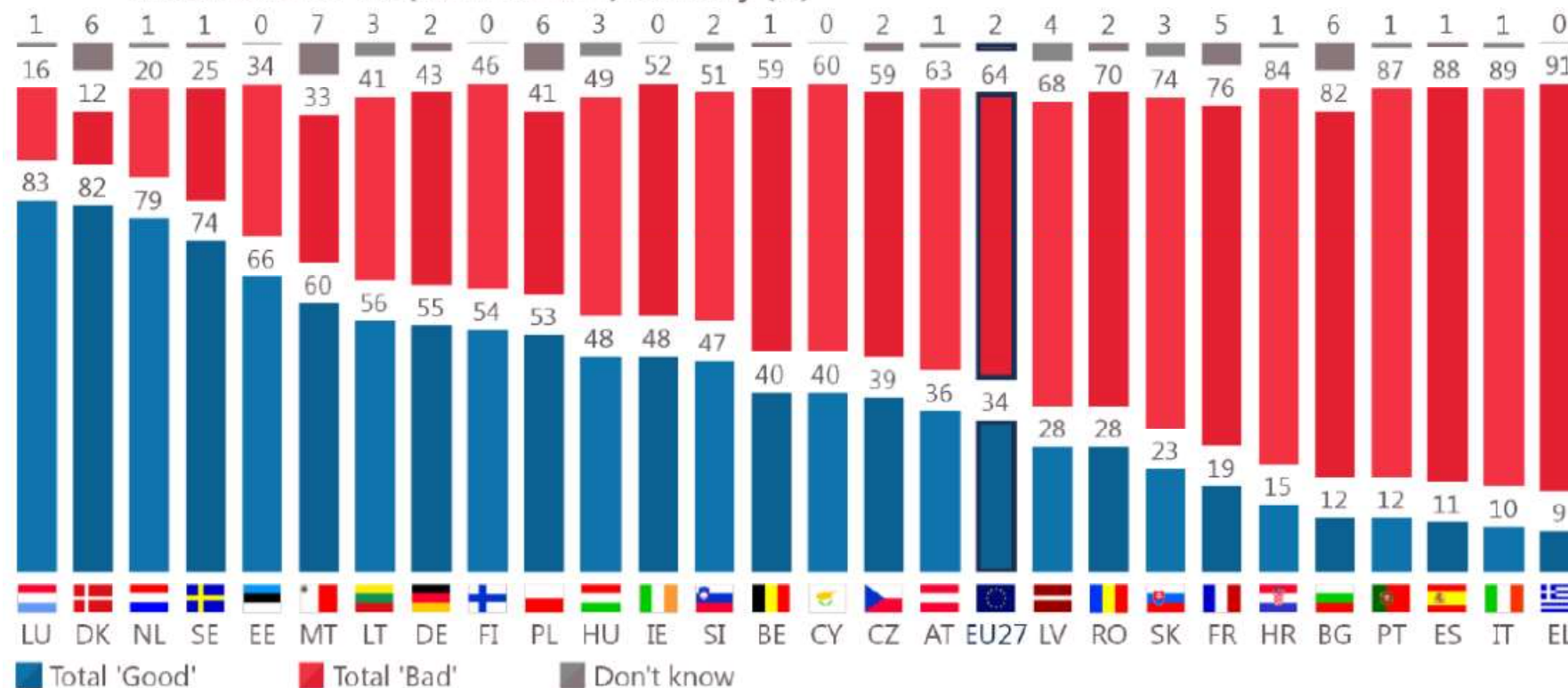
Quanto ti senti cittadino europeo ?



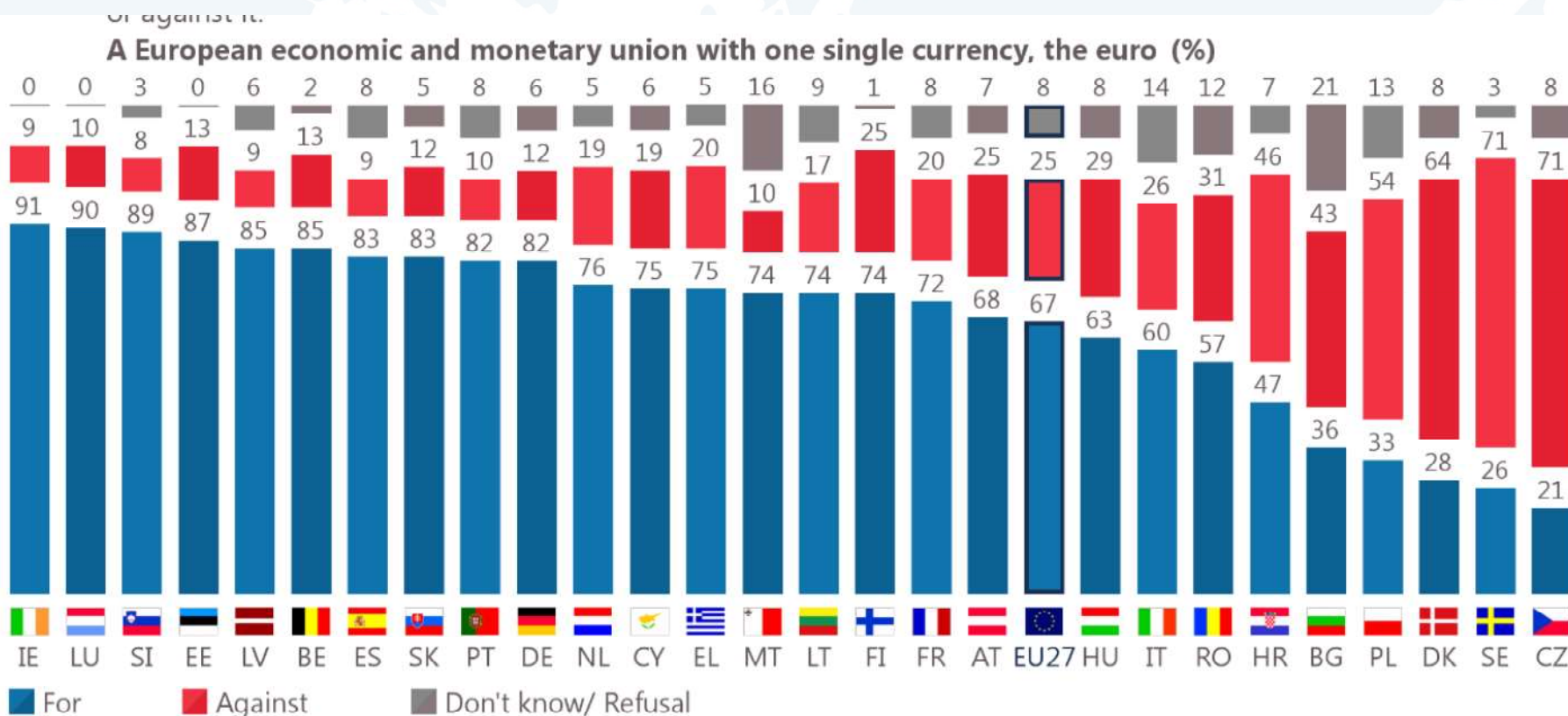
Come giudica la situazione economica nel proprio Paese ?

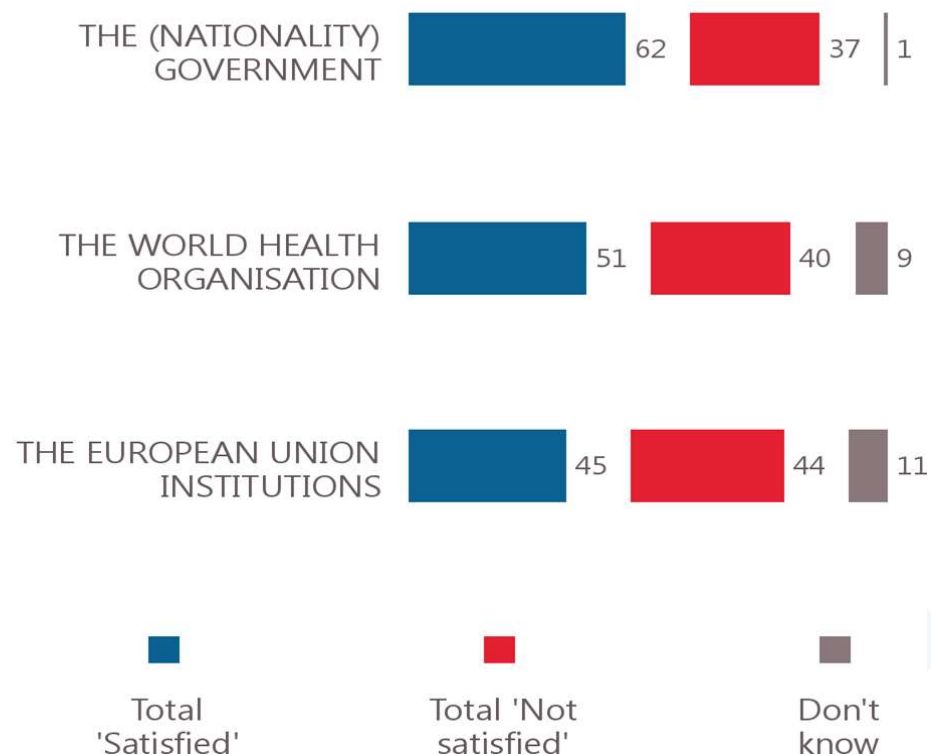

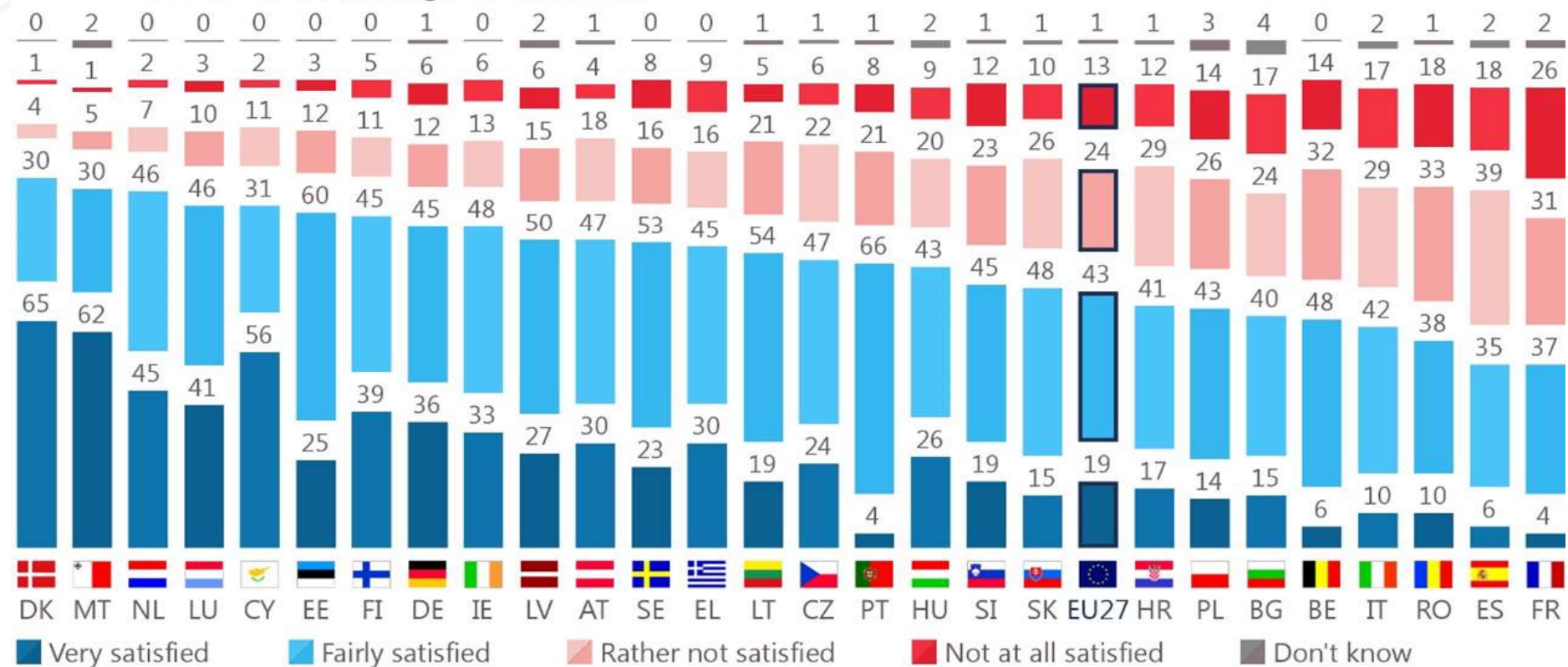
QA21a In general, how satisfied are you with the measures taken to fight the Coronavirus outbreak by?

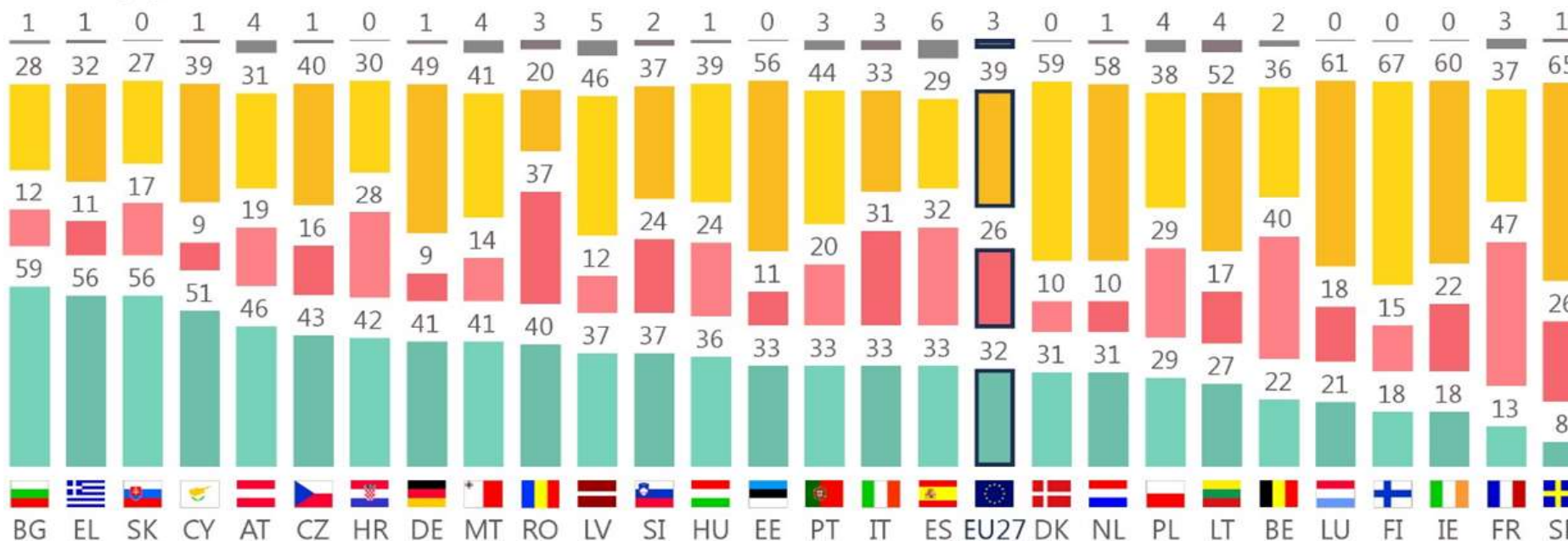

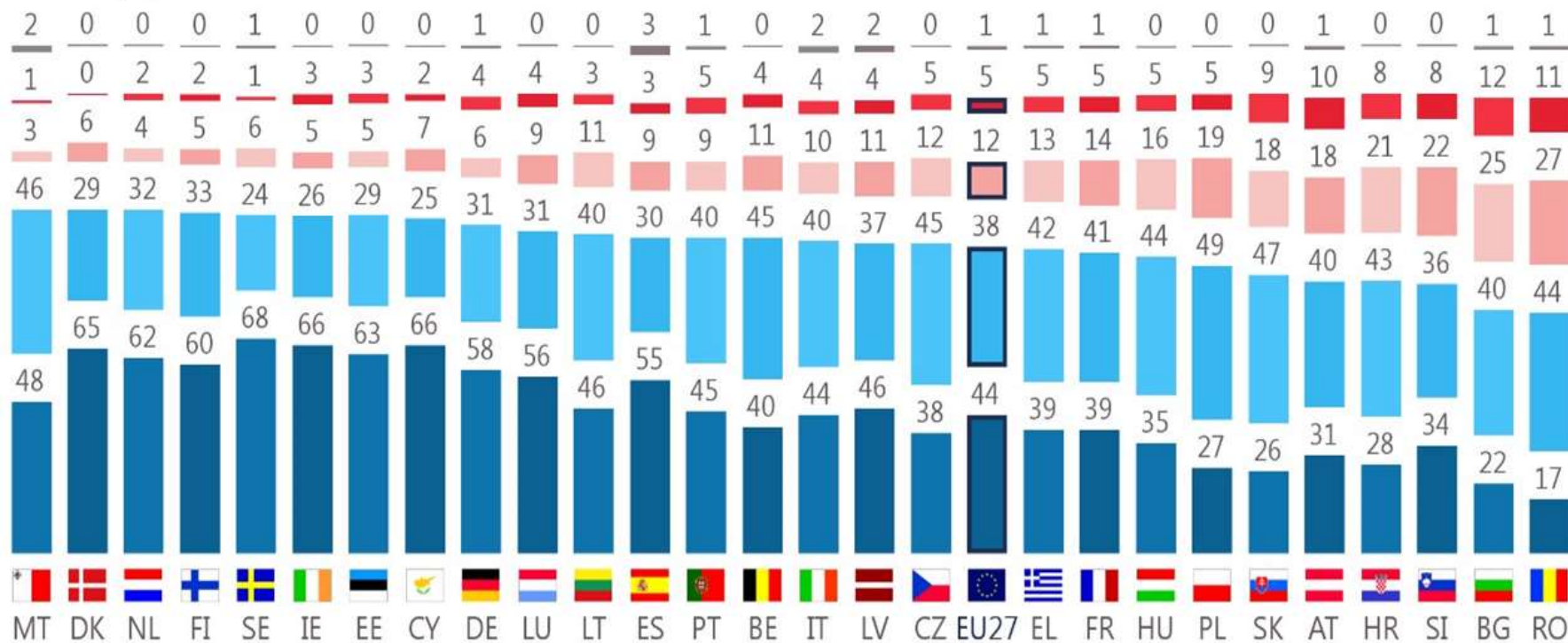

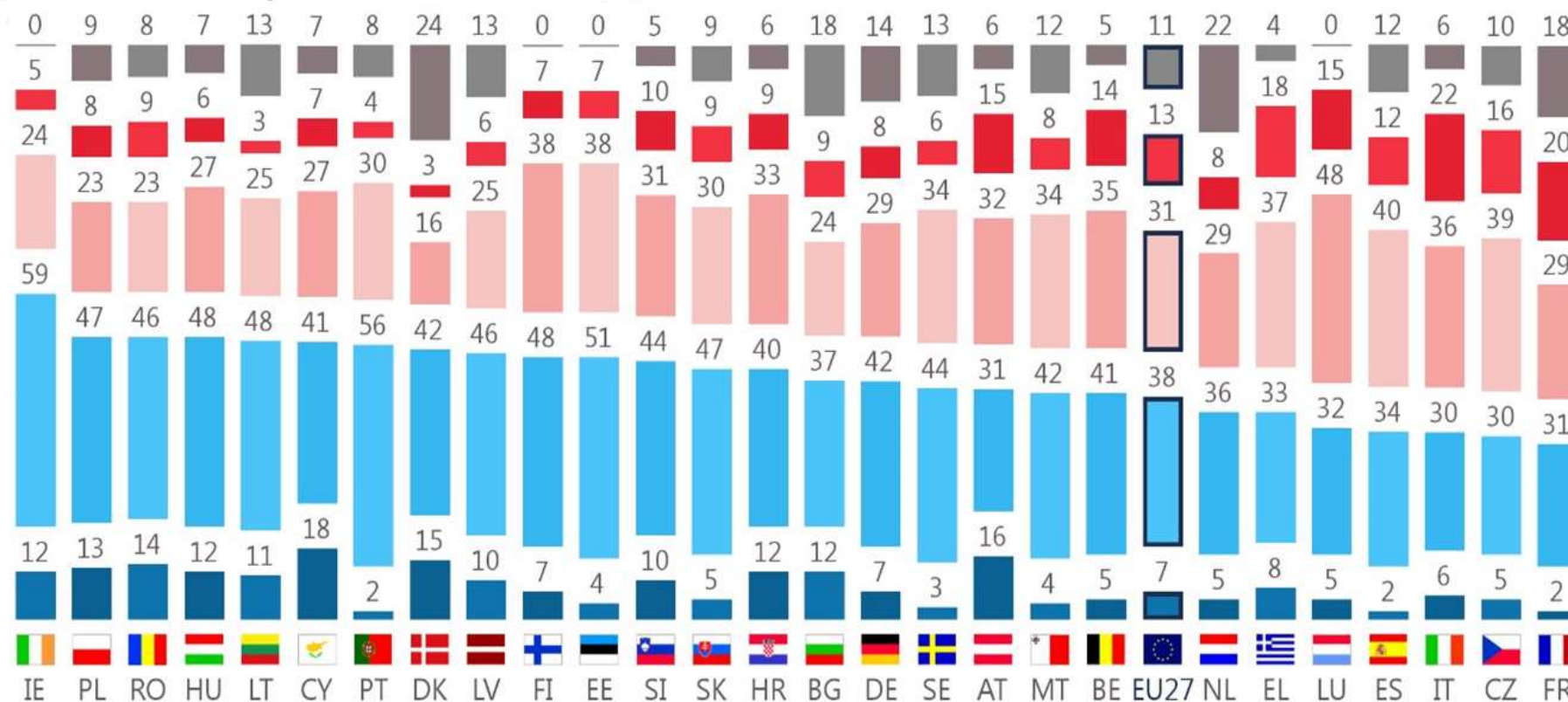

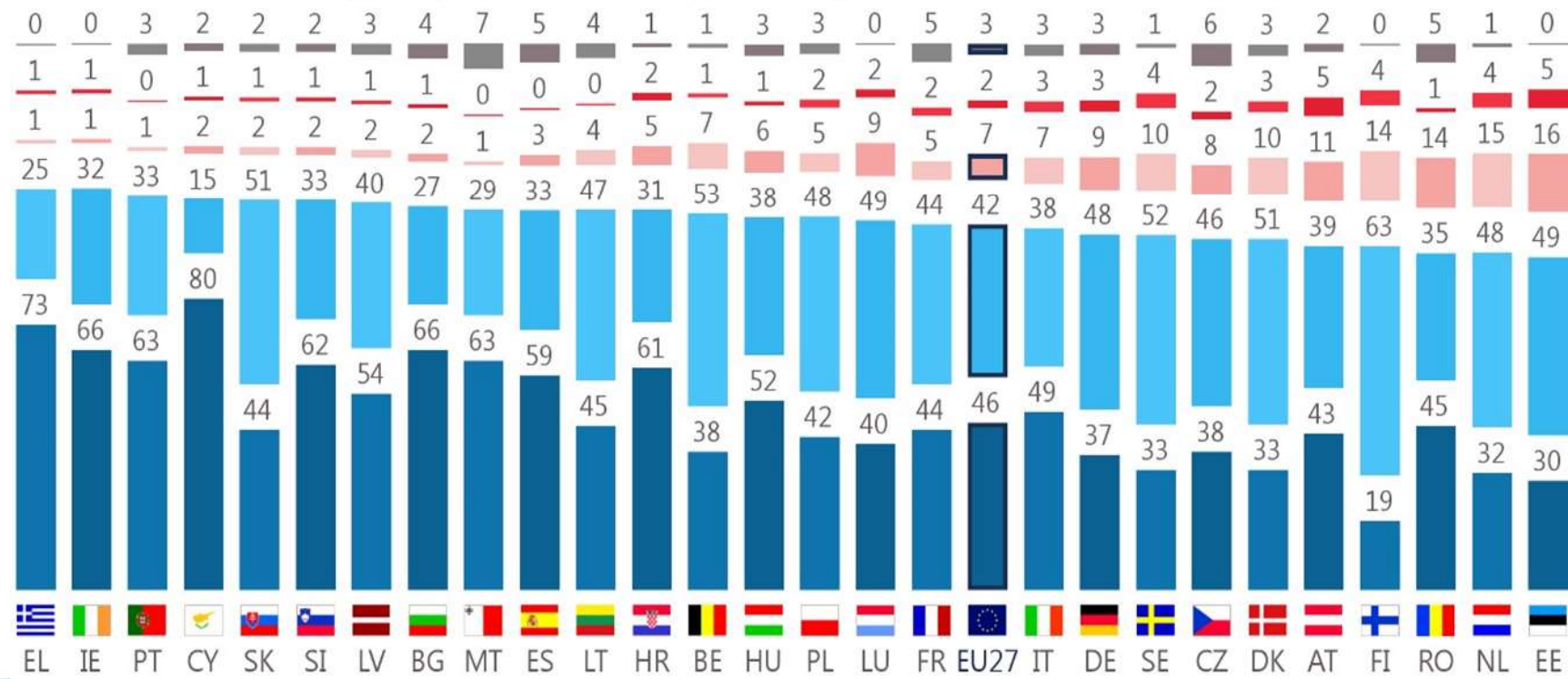

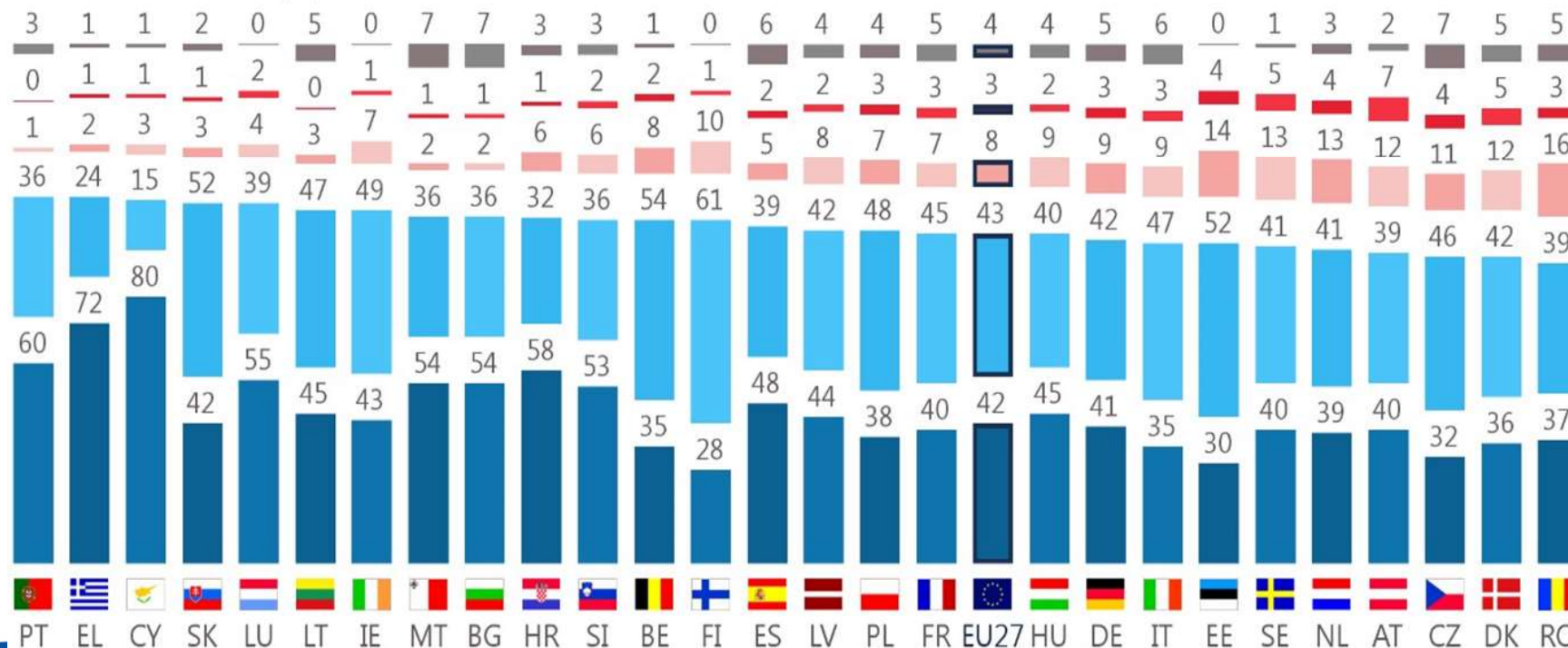

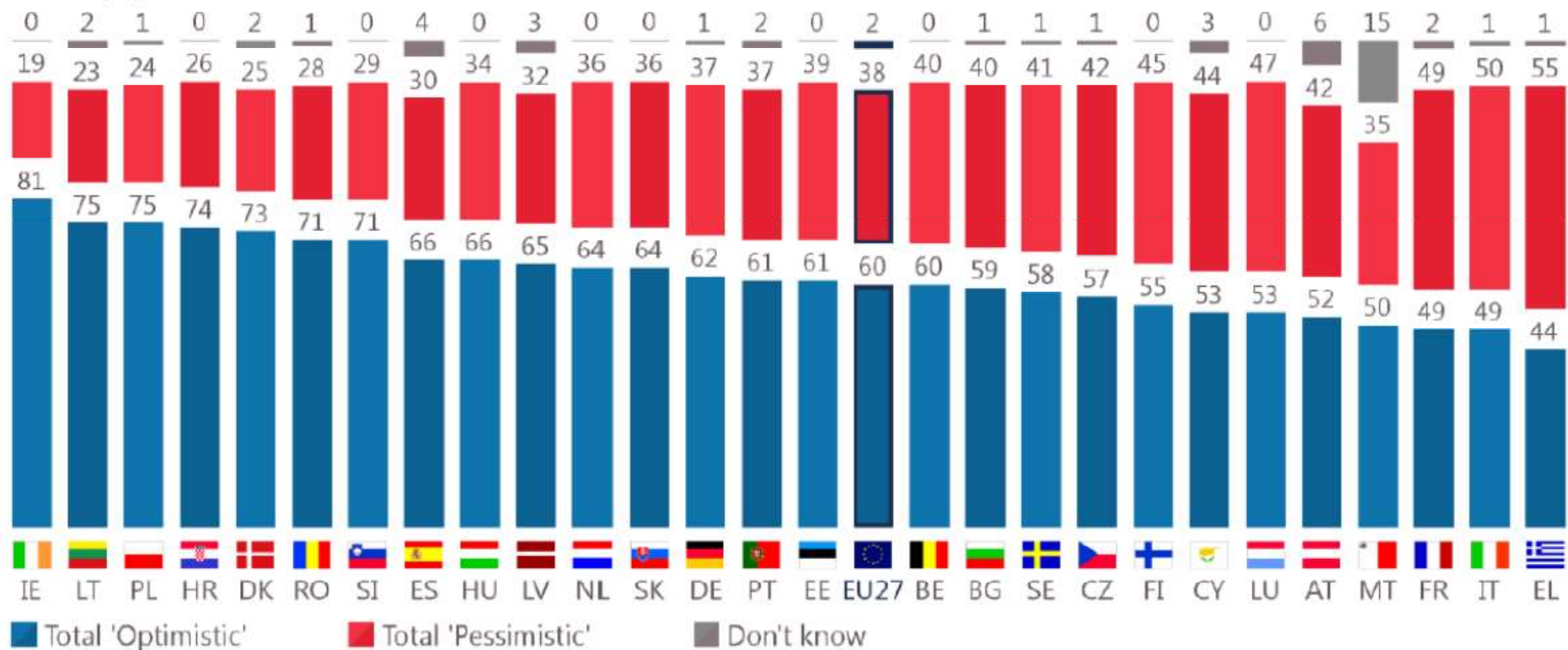
