- Europe's Beating Cancer Plan
- Global health
- Mental health

Grants – What are they?

Grants are a **donation** to a third-party (= the beneficiary) engaged in activities that serve Union policies.

Grants fall into two broad categories:

- grants for actions, intended to help achieve objectives that are part of a Union policy
- **operating grants**, that finance the functioning of a body whose objectives are part of a Union policy. These are based on a work programme.

We can have mono-beneficiary and multi-beneficiary.

A grant is a donation to finance

Procurements – What are they?



Public procurement means the **purchasing of works, supplies and services** by public bodies.

Initiative and control lie entirely with the contracting authority who produces the detailed specifications.

The **result** of the action becomes the **property of the contracting authority.**

Within public procurement, the contractor's invoice is only paid in exchange of the delivered services, as per the contract signed by both parties.

The price includes **profit** for the economic operator.

Europe's Beating Cancer Plan

• Cancer is one of the main priorities of the European Commission in the health domain.



Europe's Beating Cancer Plan is a political commitment to:

- ✓ fight cancer
- support Member States in improving cancer control and care
- \checkmark let Europe to take the lead in the domain.

- It includes actions to strengthen approach at every stage of disease: *prevention*; *early detection*; *diagnosis* & *treatment*, *quality of life* & *survivorship*
- It will have €4 billion of funding (2021-2027); EU4Health includes €1.25 billion

EU CAYAS NET: EU Network of Young Cancer Survivors

Objective: to establish a European network of young cancer survivors through the development of an interactive, virtual platform.

Project led by patient advocates, under the Europe Beating Cancer Plan

Duration: 2 years (01/09/2022 - 31/08/2024)

Total cost of the project: 6,2M EUR; EU Contribution: 5M EUR

Participants: 9 beneficiaries + 33 associated partners, from 18 countries

Expected outcome: To improve the quality of life of young cancer survivors through the creation of a knowledge center and an EU-wide multilingual platform that brings together cancer patients, health care professionals and care institutions.





EU CAYAS NET: EU Network of Young Cancer Survivors

Achievements up to present:

- The network platform is online: https://beatcancer.eu/
- Community of over 200 users, mostly young cancer survivors
- Content about topics chosen by cancer patients:
 - quality of life;
 - care for adolescents and young adults;
 - equality, diversity and inclusion
- Activities organized: trainings, peer visits, webinars, meetings, videos
